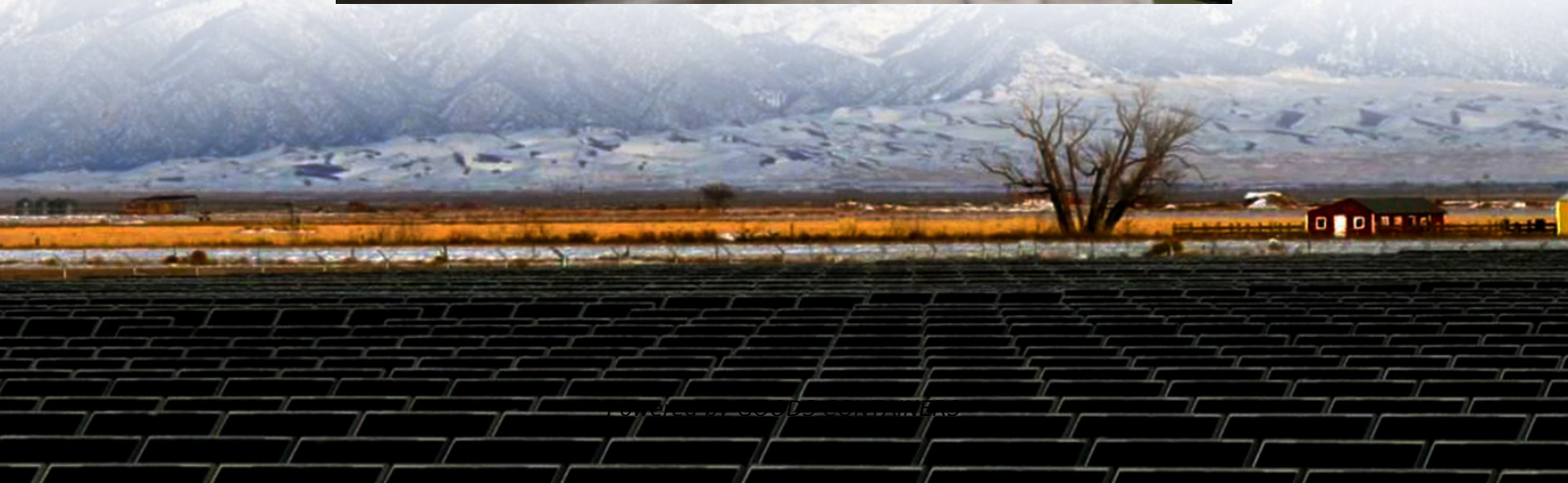

Are batteries subject to producer responsibility in Denmark?

If you produce, import, or sell batteries in Denmark, you may be subject to producer responsibility. On this page we present an outline of what to do to comply with the rules of the Battery Regulation and Statutory Order no. 986 of 20 June 2025. See what you need to do when the new Battery Regulation comes into effect.

Does European energy have a battery storage project in Denmark?

Can I resell a battery in Denmark?

Any supply of a battery for distribution or use in Denmark. This only applies when it involves a commercial activity. If you resell batteries that have already been made available by another company - and you do not change the product or the marking - you are not subject to producer responsibility for batteries. Which types of products are covered?

How does the Danish Environmental Protection Agency regulate batteries?

The Agency carries out control and supervision of compliance with the rules of the Battery Regulation and Statutory Order no. 986 of 20 June 2025. This also means that any complaints against decisions made by DPA may be brought before the Danish Environmental Protection Agency.

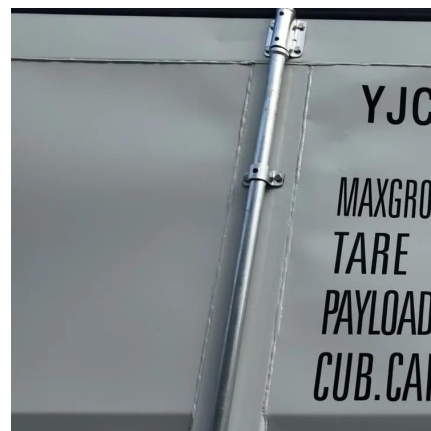
