How has Nepal customs tariff 2081-82 changed?

The recent implementation of Nepal customs tariff 2081-82 brought changes to duty structures. These generally reflect a trend of reduced duties on technology imports and increased taxation on luxury goods. For precise duty rates, businesses should refer to the official Nepal Customs Tariff 2081-82.

What are import tariffs in Nepal?

Import tariffs in Nepal generally range from 0-80% ad valorem. Most goods are subject to customs duties between 5-30%. Raw materials and basic goods typically have lower rates of 5-10%, while luxury and non-essential items face higher duties of 30-80%. Nepal uses the Harmonized Tariff System for classification.

What tariff system does Nepal use?

Nepal uses the Harmonized Tariff System (HTS) for classification purposes. Import duty rates vary from zero to 80 percent. There is a two-tier tariff rate system for most imported items - one for imports from South Asian Association for Regional Cooperation (SAARC) nations, which is usually lower than for imports from all other non-SAARC countries.

What is the VAT on imports in Nepal?

The VAT on imports in Nepal is generally 13%. It applies to most goods entering the country, alongside other applicable customs duties. How can I check custom duty?

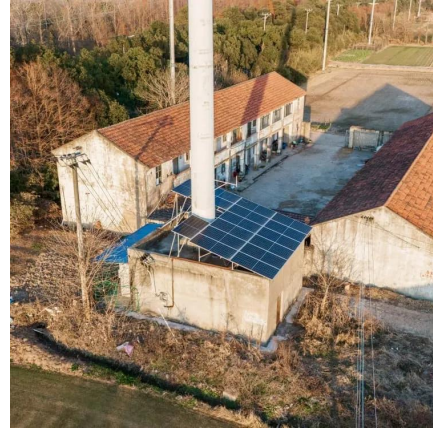
